The project will dualize about 536 kilometers (Km) of provincial highways in south Punjab from the existing two-lane to divided four-lane standards with road safety and climate resilience features. It will also engage concessionaires to conduct operations and maintenance for the project roads through tolling and performance-based maintenance approach.

It will also support the government to (i) establish a dedicated entity with streamlined funding to manage all provincial highways in Punjab; (ii) conduct road safety assessment for the provincial highway network of Punjab and pilot the Safe System approach with a framework and action plan; and (iii) improve climate resilience of the road network and Communication and Works Department's disaster-response capability.

### Objective and Scope:

The subject consultancy package will be responsible to supervise Road Package comprising of **Corridor-1: Rehabilitation of Chichawatni – Kamalia – Pir Mahal – Shorkot – Garh Maharaja – Chowk Azam – Layyah; and Corridor-2: Rehabilitation of Chiraghabad Interchange at M-4 – Jhang Bypass – Shorkot (total 311 Km).**

### Consultancy Services:

The consultant team will be headed by Chief Resident Engineer/Team Leader and will comprise national key experts. The person-months of National Experts input are tentatively mentioned in the following table.
